9:05 Jamie Hintz Highway Superintendent

Hintz discussed several highway related issues with the Commissioners. He said they are very busy mowing and two from the highway dept. are fall spraying. Hintz said they will be starting the overlay project on County Road #6 today and if all goes well the project should be done by the end of the week. He said the computer at highway office needs to be replaced and will get a quote for replacement.

9:15 John Deere Sales Representative

A sales representative, Chad Kesteloot from RDO Equipment Co, met with the Commissioners and explained the lease purchase program and purchase out right of motor graders. These machines are used, previously leased by City of Sioux Falls; have the same warranty as new machine; total cost for 2016 John Deere 772G with warranty for 96 months; new 2016 Little Falls Machine 12Wing; off state bid pricing the cost of unit would be \$302,248.01 per unit. 2) Jaeger moved, seconded by Rhody to purchase one unit, John Deere 772G Motor Grader at cost of \$302,248.01 in 2016 and additional unit at same cost in 2017. All voted yes and the motion carried.

10:00 Tammy Baer Community Health Nurse Quarterly Report

Baer met with the Commissioners and gave them a quarterly update of the Community Health Nurse Office activities. Baer said that WIC numbers were down slightly from the previous quarter. Baer stated they have done a lot of flu clinics so far this year; 224 children and 40 staff members participated in the Deuel School clinic. She said in October the state reported the first case of influenza in SD. Baer stated regionally they have hosted 15 flu clinics in and around Deuel County and they also hold weekly clinics in their office with the 17th of Nov. being the last flu shot clinic at the Community Health Office.

10:30 Weed Supervisor Keith Goens

Goens met with the Commissioners and gave an update on the fall weed spraying. He said they are still spraying townships and still doing some of the state roads. He talked about advertising early next year for seasonal help for weed spraying in the spring. Goens requested approval to attend weed meeting Nov. 4. 3) Jaeger moved, seconded by Pederson to approve travel for Weed Supervisor and Weed Board member to attend meeting in Nov. All voted yes and the motion carried.

10:45 Director of Equalization Donna Rhody-GIS System

Director Rhody requested the Commissioners determine what pricing will be used to obtain information off the Deuel County website that will provide real estate information. She presented charges and additional information and possible agreements

from surrounding counties and how they handle the use of their websites and computer records.
